"Polysafe Stud Tile" (or "Polystud"):

Decorative pressed, raised stud, single layer homogeneous synthetic rubber floor tile.

Thickness: 3 mm.

Weight per unit area: 4.8 Kg/m2.

Substrate for both testings: calcium silicate based board 12 mm thick and of 870 kg/m3 density.

Adhesive application rate: 200 g/m2 (acrylic based: F Ball & Co, "Styccobond F44").

2. DOCUMENTS AND DRAWINGS:
